

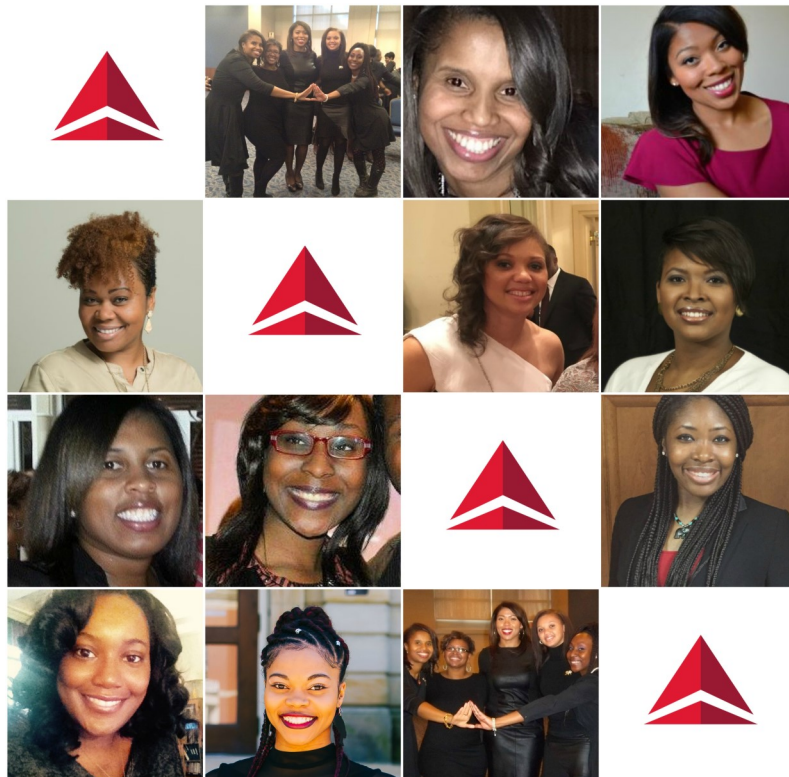

HATTIE J. HILLIARD

was an artist, a graphic design professor, and a corporate graphic specialist. In 1965, she became a member of **Delta Sigma Theta Sorority** at Alpha Nu Chapter on the Urbana-Champaign campus of the University of Illinois; in 1967, she graduated with a Bachelor's Degree in Fine Arts. She was awarded a Fulbright Fellowship to teach graphic design at Ahmadu Bello University in Zaria, Nigeria. In February, 1995, she died in an automobile accident near Mokwa, Nigeria. Hattie was a good cook, gracious hostess, photographer, and inspiration to students, friends, and family.

The scholarship, established in her honor by her contemporary Sorors, is available to **Delta Sigma Theta** Sorors enrolled at the Urbana-Champaign campus. Preference is given to undergraduate Sorors of Alpha Nu Chapter.

ALPHA NU HELPING ALPHA NU: THE HATTIE HILLIARD SCHOLARSHIP & ENDOWMENT FUND

In 1999, early 60's Alpha Nu Deltas established the Hattie Hilliard Endowment Fund (HHEF) to generate scholarships for Alpha Nu Deltas enrolled at the University of Illinois' Urbana-Champaign campus. Preference goes to undergraduates.

Here's how it works: by agreement between the University and the 60's Deltas who created the Fund, the Office of Student Affairs annually awards a scholarship based on an applicant's academic achievement, financial need, and community service. Endowment funds are managed by the University of Illinois Foundation that invests the pooled monies of the HHEF and other relatively "small" endowments. The Foundation Board determines the amount of money available for an annual HHEF scholarship based on pool earnings and the HHEF's share of the pool - the more money in the HHEF, the larger its share of pooled earnings, the larger the scholarship and (some day) the more scholarships.

Making the Fund self-sustaining is a goal and opportunity for you to invest in the Chapter with which you may have been affiliated by assisting current Alpha Nu Sorors who need financial aid.

Here's how you can help:

- (1) You can contribute to the Fund. The University of Illinois Foundation is tax exempt under Internal Revenue Code Section 501(c)(3). Send funds to the address below. The Foundation will promptly acknowledge your gift.
- (2) You can forward this brochure to other Alpha Nu Deltas, other potential donors, and eligible scholarship applicants. Scholarship applications are usually accepted in January, but interested applicants should contact the Office of Student Affairs to confirm application dates and deadlines.
- (3) You can suggest the Fund for your employer's matching contributions program; if so, send your employer's matching funds form to the address below; and
- (4) On advice of your attorney working with the University of Illinois Foundation, you can designate the HHEF to receive all or part of your estate as a direct or contingent beneficiary.
